Re: Remove or Repair of the Structure at 1033 Galtier Street

Dear Mr. Soczynski:

This is to confirm that on October 8, 2020, Marcia Moermond, Legislative Hearing Officer, recommended laying the matter over to Legislative Hearing Tuesday, January 12, 2021 via phone between 9:00 a.m. and 11:00 a.m. At that time the following conditions must be met:

- 1. Please make sure property is open and accessible for the code compliance inspection to be completed. Contact Nathan Bruhn at <u>nathan.bruhn@ci.stpaul.mn.us</u> or 651-266-9033 once you have verified property is accessible via lock box;
- 2. submit evidence of financing sufficient to complete the rehabilitation. Staff estimates cost exceeds \$100,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis;
- 3. submit an affidavit indicating the finances will be dedicated to complete the project and not diverted until a code compliance certificate is issued;
- 4. submit work plan, sworn construction statement, or scope of work. This should include subcontractor bids and a schedule for completion of the project; and
- 5. the property must continue to be maintained.

If you wish to contest to this recommendation and give live testimony remotely at the City Council Public Hearing **January 13, 2021 between 3:30 p.m. and 5:00 p.m.**, please contact me at 651-266-8515 or <u>Councilhearing@ci.stpaul.mn.us</u> to let our staff know before noon on Wednesday.
