ARP Distribution to State and Local Governments

- The American Rescue Plan (ARP) allocates \$350 billion to states, territories, Tribes, and local governments.
- Saint Paul anticipates receiving \$172 million of one-time funds, half within 60 days of the bill's passage and half 12 months later.
- Funds must be spent by December 31, 2024.
- Anticipate additional guidance from the US Department of Treasury.





Eligible Expenses

- Respond to the COVID-19 emergency and address its economic effects, including with aid to households, small businesses, nonprofits, and industries like tourism and hospitality.
- Provide premium pay to essential employees or grants to their employers.
- Provide government services affected by a revenue reduction resulting from COVID-19.
- Make investments in water, sewer, and broadband infrastructure.
- Transfer funds to nonprofit groups and units of state or local governments.
- Funds may not be used for pensions or to offset revenue resulting from a tax cut enacted since March 3, 2021





Initial Strategy

- Recommend the City create an overarching strategy for ARP funding addressing:
 - Priorities of community, Council, City
 - Strategy to address immediate needs and plan for the future
 - Analyze City's fiscal needs
 - Outline internal processes and logistics
 - Prepare for long-term management of funds
 - Consider other federal sources

Other Sources for Community Support

- \$2.57M to State of Minnesota
- \$106.7M to Ramsey County
- Direct aid to families
 - Economic impact payments of up to \$1,400 for individuals plus \$1,400 for qualifying dependents
 - Increased Child Tax Credit maximum
 - Additional \$1,000 Earned Income Tax Credit relief
- Small business assistance
 - Additional \$7.25B for the Paycheck Protection Program (PPP) forgivable loans.
 - \$15B for targeted Economic Injury Disaster Loan for businesses located in low-income communities that have suffered economic losses.
 - \$25B for eligible restaurants, bars, and other businesses providing food and drink to cover pandemic-related revenue losses up to \$10 million per entity or \$5 million per location limited to 20 locations.
 - \$1.25 billion for shuttered venue operators.





Other Sources for Community Support

- Health and human services
 - \$47.8B for testing and contact tracing, \$8.5 billion for CDC vaccine activities, including additional funding for state, local, and territory vaccine distribution grants.
 - \$7.66B for state, local, and territorial public health departments to support public health workforce.
 - \$3B in Substance Abuse and Mental Health Services Administration block grant funding.
 - \$800M for health workforce.
 - \$39B in total funding for childcare
- Housing and utilities
 - \$27.4B in Emergency Rental Assistance (State of MN estimated to receive \$200M)
 - Similar to Emergency Rental Assistance authorized in December 2020 and includes homeowner assistance fund of \$9.96B.
 - \$4.5B for the Low-Income Home Energy Assistance Program.
 - \$500M for Low-Income Household Drinking Water and Wastewater Emergency Assistance Program for assistance with payments for drinking water and wastewater expenses for low-income households.






Process and Timeline

- Spending Guidance from Treasury April May
- First payment by 5/10/21
- Accept funds via Council Resolution Mid-May
- Budget Amendment(s) for immediate needs/crisis response May-Aug
- 2022 Proposed Budget Mid-August

Immediate Need

- Downtown Public Safety Strategy
 - Compared to pre-pandemic, we have seen an increase in unsheltered homelessness. Many individuals appear to have mental health and/or chemical dependency challenges. This contributes to an environment where individuals are being preyed upon by drug traffickers.
 - Objectives:
 - Increase our ability to connect individuals in need to resources; and
 - Ensure the downtown public realm is safe and well maintained as businesses transition to bringing their employees back to the office, and venues reopen for special events.
 - Collaboration by multiple City departments, governmental agencies, non-governmental agencies and non-profits, as well as community members, business owners, and managers.

Estimated funding needed for implementation of the plan:

Enforcement operations (narcotics sales, other targeted criminal activity that may be identified)

• 10 enforcement operations = \$125k

On-Going Maintenance with a rotating schedule and ability to patrol all area action plan locations based on deployment needs. Staffing will start in April and go through November (can go longer with additional funding)

• Cost is \$25k per week, 34 weeks (approx.) = \$850k

Total Ask for initial enforcement and on-going maintenance = \$975k
