

Introduction

Charter School Property, Inc., an Affiliated Building Company for St. Paul City School, is interested in purchasing the HRA-owned parcel (Property ID: 36-29-23-14-0093) located at 192 Sherburne Avenue, Saint Paul, MN 55103-2037. We would like to purchase the lot for its appraised market value of \$170,000. We would like to close on the purchase as soon as possible.

Project Summary

Charter School Property, Inc., is an Affiliated Building Company for St. Paul City School and is working to purchase and redevelop the site located at 215 University Avenue West, St. Paul, MN. We have a signed purchase agreement for the property from the League of Minnesota Cities Building Company. The HRA-owned lot at 192 Sherburne Avenue is surrounded by the League of Minnesota Cities Building Company's parcels on three sides and will be used as part of the school's access drive and parking lot if it can be secured. The existing three St. Paul City School campuses will relocate to the new site in a single facility that will serve students ranging from Pre-Kindergarten through the twelfth grade. Charter School Property, Inc. is working to arrange financing for this project using New Market Tax Credits. The total cost of the 65,900 square foot development including building acquisition, demolition, construction and related costs is estimated at approximately \$16,300,000. We are looking to close the project financing on February 1, 2021, begin construction March 1, 2021, and occupy the building in December 2021.

The new facility will be located on a 1.79 acre site located at 215 University Avenue West, St. Paul, MN 55103. The site is currently tax exempt and owned by the League of Minnesota Cities Building Company. The 65,900 square foot building will be new, ground up construction with 28 classrooms of 750 sf each, 3 flex rooms of 750 sf each, 13 pullout spaces for small group learning, Music, Art, Media Center a 6,270 sf gymnasium, a serving kitchen, outdoor play space, associated office and administrative space, and restrooms. We are also planning to build approximately 60 parking spaces and an outdoor play area.

Consistent with the St. Paul City School's mission, the new facility will also have a community center that will be accessible to the community at large in the evenings and weekends. The community center will offer services like food distribution, navigating health care, legal services, and federally funded clinic in collaboration with Minnesota Community Care.

The proposed site for the new St. Paul City School campus lies within the Capitol Area controlled by the Capitol Area Architectural and Planning Board. St. Paul City School is currently coordinating design and zoning approvals with the Capitol Area Architectural and Planning Board.

About St. Paul City School. St. Paul City School is a preschool through 12th grade public charter school district located in St. Paul, Minnesota. St. Paul City School was founded in 1998 and will serve approximately 620 students at the new campus.

School Demographics

St. Paul City Schools was first established in 1998 with a population of around 200 students. River's Edge Academy was founded in 2009 as an environmental high school with a focus on small class sizes and experiential learning. St. Paul City School and River's Edge Academy charter school districts merged as of July 1, 2019 and today, enrollment district-wide is now 600 students. The demographic breakdown is 40% Latino, 25% African American, 25% Hmong, 5% White/Caucasian, and 1% Native American; approximately 90% of our students qualify for free/reduced lunch; and 100% are hardworking and resilient people!

Academic Performance

St. Paul City School's student population is almost entirely made up of children who receive free or reduced price lunch as part of the US Department of Agriculture's free and reduced lunch program. When looking at the education outcomes of these students versus the same population of students in the traditional St. Paul Public School system, St. Paul City School's students are out preforming in both academic achievement and academic growth.
