On 01/02/2020 at 2003 hours, we squad 172 (Officers R. Pinoniemi/Busch) were sent to 1877 Grand Avenue #203 for a suicide in progress report. While en route to the location, we received information from the complainant on the phone, who verbally identified herself as EMILY ANN LACKNER (DOB: 08/09/1992, 1159 Churchill Street, C/P: 651-404-9194). LACKNER said that her ex-boyfriend (JAMES ROBERT LEE NELSON, DOB: 07/22/1988, 1877 Grand Avenue #203, C/P: 651-404-5227) that she broke up with approximately one year ago sent her an email saying that he ingested pills, and that he loved her, and would see her in his next life.

LACKNER said that NELSON never had threatened suicide in the past, but she thought that he was mad at her for not talking to him. Based on the above when we arrived on scene, we attempted to make contact with NELSON by knocking on the door and announcing ourselves as SPPD Officers, but NELSON would not answer the door. St. Paul Fire then arrived on scene and kicked in the door. We then handcuffed NELSON. NELSON was awake, and we did not see any injuries to him. NELSON walked out to a St. Paul medic rig with officers. NELSON was transported to Regions Hospital by St. Paul medics (rig number 14/run number 251) to be evaluated by their psychological medical staff.

No force was used.

I, Officer L. GOULET (sqd #451) am currently assigned to the Community Outreach and Stabilization Unit (COAST) with the St. Paul Police Department. In this assignment, I serve as a liaison between the St Paul Police Department and mental health resources within the city. I also attempt to connect people in crisis with mental health resources when asked for or in need of services.

I was assigned to review this case for possible follow-up and referral. I began by reviewing all included reports and information for the parties involved, to determine the best course of action. The officers on scene did not locate any evidence or I information that would indicate a crime had been committed.

In this particular incident officers spoke to: JAMES NELSON, dob 07/22/1988.

I called and spoke to NELSON who explained he was having a bad day on 01/02/2020. He recently lost his job and has some major medical problems.

Everything is better now and he is getting help. I advised him to call if needed in the future.

I found no police mental health related calls for service involving this subject within the last twelve months.

At this time the case will be NOTED. If additional police mental health contacts are reported this case will be considered for further follow up or referral to an outside agency.
