RE: Potential Stay of City Removal Order of the Structure at <u>1179 Seventh Street East</u>

Dear Sirs:

This is to confirm that on January 13, 2021 at the City Council meeting, Marcia Moermond, asked the City Council to refer the matter back to Legislative Hearing **March 23, 2021 via phone between 10:00 a.m. and 12:00 p.m.** and continuing the stay of enforcement through April 16, 2021. Please note the following conditions must be met by close of business March 22, 2021:

- 1. a new \$10,000 performance deposit is to be posted by purchaser;
- 2. submit work plan, sworn construction statement, or scope of work. This should include **signed** subcontractor bids and a schedule for completion of the project;
- submit evidence of financing sufficient to complete the rehabilitation. If total for bids are more than 20% less than staff estimate (previous estimates have been calculated at upwards of \$1,000,000), a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis;
- 4. Submit an affidavit indicating the finances will be dedicated to completing the project and not diverted until a code compliance certificate is issued; and
- 5. the property must continue to be maintained

You may submit those documents to <u>legislativehearings@ci.stpaul.mn.us</u> or in person at our office at 15 W. Kellogg Blvd, Room 310 between 9 a.m. and 3:30 p.m. Monday through Friday. I have attached samples for your reference.
