I have not reviewed my BWC prior to this report. The following is a summary of what occurred.

On 03/15/2020 at 00:46 hours I, Squad 221 (Ofc. Wolfe), responded to 413 Wacouta St on a call of suspicious activity. It was reported by Noval Stewart (DOB: 10/18/1980, C/P: 612-442-2181) that they saw a suspicious gray Buick sedan drive down the alley, and noticed a broken window on the side of the Gilbert Building.

Upon arrival I located a broken window on the North side of the building on the main level. I noticed cords hanging off of a shelf, as if something had been pulled off the shelf. I notified dispatch and requested a K9 to respond to the scene.

Squad 214 (Ofc. Langr), K9 Squad 628(Ofc. Caron), and I searched the building for suspects with negative results. We noticed what appeared to be a possible TV missing from the shelf or wall, directly across from the window that had been smashed. There was also a rock on the ground in front of the shelf, possibly what was used to damage the window.

I attempted to call multiple phone numbers of the business, Adagio Djay Entertainment (C/P: 612-787-3501), to
