#### NARRATIVE

On 11/14/2020 at 21:18 hours I (M.Brodin SQD 173) was dispatched to 1800 UNIVERSITY AVE W for a criminal damage report.

I arrived on scene and spoke to the witness, later identified as Michael D Simmons (DOB/1988-01-13 1698 Edmund Avenue 651-724-3985) who said he saw the suspect damage the window.

SIMMONS told me he is the night manager at Arbys 1810 University Ave. SIMMONS said he saw the suspect he described as a B/M 5'8" to 5'11" wearing a long brown coat with blue jeans. SIMMONS said he watched the suspect through Arbys front window, pick up a construction road metal hazard barrier and smash it against a window of the building next door causing it to break. SIMMONS said the suspect then threw down the barrier and walked E/B on the south side of University. SIMMONS said the suspect never made any attempt to gain access to the business.

I then walked to the business Hotel Furniture Liquidators and noticed there was a broken window on the west side of the business. There was no entry made to the business. I searched in RMS and located the owner later identified as Michael Albert Hafner (DOB/1949-03-24 6247, Lightborne Way Naples FLORIDA, C/P 612889-6331 Email: euros\_2001@yahoo.com) and notified him of the incident. HAFNER requested that I call a board up crew to secure the window because he was out of town and unable to respond.
