Dear Mr. Johnstone & Ms. Fleming:

This is to confirm that on March 23, 2021 at the Legislative Hearing, Marcia Moermond, the Legislative Hearing Officer recommended that the City Council **grant to April 16, 2021 for compliance the vehicle abatement orders written on the RV.** Compliance means it needs current tabs and needs to be able to be driven legally on the street.

On April 20, 2021 at 11:00 a.m. via phone there will be a making-finding hearing to determine if the April 16 deadline was met and the nuisance was abated. The public hearing on that will be April 28, 2021 at 3:30 p.m.

Ms. Moermond also recommended that the City Council grant to April 1, 2021 for compliance with the condemnation and vacate orders dated March 17, 2021.

The City Council Public Hearing for both these items is scheduled for April 7, 2021 at 3:30 p.m. Due to the COVID-19 pandemic, **we will not be holding hearings in person.** If you are contesting Ms. Moermond's recommendation, you may send written testimony to be added to the record to <u>legislativehearings@ci.stpaul.mn.us</u> or by voicemail at 651-266-6805. If you don't wish to contest, no further action is needed.

As discussed in the hearing, if you haven't already connected with Ms. Lauren Lighter from Ramsey County House calls, please do so.
