Re: Appeal for Property at 1352 Seventh Street West

Dear Mr. Johnstone & Ms. Fleming:

This is to confirm that on Wednesday, April 7, 2021 Ms. Moermond asked the City Council to refer the matter back to Legislative Hearing on April 20, 2021 via telephone between 11:30 a.m. and 1:00 p.m. for an update on the conditions at the property from Fire Inspections. You have an appointment on Wednesday, April 14, 2021 at 2:30 p.m. for a Fire Inspector to inspect your property. If you do not comply with this inspection and allow access, Ms. Moermond will assume the property is not in compliance and the apartment will be vacated.

This matter will again go before City Council on **Wednesday**, **April 21**, **2021 at 3:30 pm**. If you will wish to contest the recommendation Ms. Moermond makes on April 20, you may send written testimony to be added to the record by noon on the 21 to <a href="legislativehearings@ci.stpaul.mn.us">legislativehearings@ci.stpaul.mn.us</a> or by voicemail at 651-266-6805. If you don't wish to contest, no further action is needed.

Additionally, she recommended you have until **April 23, 2021 for compliance the vehicle abatement orders written on the RV.** As noted previously, compliance means it needs current tabs and needs to be able to be driven legally on the street. On April 27, 2021 at 11:00 a.m. via phone there will be a making-finding hearing to determine if the April 23 deadline was met and the nuisance was abated. The public hearing on that will be May 5, 2021 at 3:30 p.m.
