Dear Ms. Johnstone, Ms. Fleming & Ms. Skar:

This is to confirm that on Tuesday, April 27, 2021 Ms. Moermond recommended that the City Council grant your appeal of the order to vacate on the condition the plan submitted on April 27 is executed prior to reinspection on April 6, 2021 at 1 pm. She also recommended the City Council grant to June 1, 2021 for compliance with the vehicle abatement order.

The City Council Public Hearing is scheduled for May 12, 2021 at 3:30 p.m. Due to the COVID-19 pandemic, **we will not be holding hearings in person.** If you are contesting Ms. Moermond's recommendation, you may send written testimony to be added to the record to <u>legislativehearings@ci.stpaul.mn.us</u> or by voicemail at 651-266-6805. If you don't wish to contest, no further action is needed.

A making finding resolution for the vehicle abatement order will be scheduled for **June 8**, 2021 at 11:00 a.m. via teleconference to determine if the nuisance is abated on deadline. The public hearing on that is June 16, 2021 at 3:30 p.m. Due to the COVID-19 pandemic, we will not be holding hearings in person. If you will be contesting Ms. Moermond's recommendation after the June 8 hearing, you may send written testimony to be added to the record for the June 16th public hearing to legislativehearings@ci.stpaul.mn.us} or by voicemail at 651-266-6805. If you don't wish to contest, no further action is needed.
