Ms. Zimny and Ms. Moremond:

Please take note that a new video has been posted in connection with the upcoming hearing regarding conditions and inspection items outstanding in the Matter of Michelle Baker. I previously provided a written statement from my staff that Ms. Baker attacked the USPS carrier — a federal offence. Our mail service to the building was subsequently suspended for several days...effecting 120 other people. We just cannot have this go unaddressed.

We were able to get the mail service restored, and my Regional Manager then interviewed the postal worker to understand the circumstances of the Baker assault. That video link is noted below.

I understand that Inspector James Thomas inspected the property without notice on Friday, April 30, 2021. I would welcome learning what conditions he found the unit in, relative to videos we showed earlier in the week. I herewith request copies of his report so my legal team can review in preparation for the upcoming hearing.

Based on the preponderance of the evidence we are going to re-file for eviction on Monday. I hope the city does not oppose us this time.

Ms. Baker is a danger to herself, a hazard to other residents and needs to be in special housing – not the general population. Her repeated damage to property justifies us deferring the non-life safety minor items like closet doors, kitchen cabinet door and vinyl floor damage until she is removed from the premises. We pledge to keep the minimum life safety services in working order – but she is a constant drain on our maintenance resources. She flooded her kitchen again last week... she could not figure out how to operate a dishwasher.
