Revocation of Fire Certificate of Occupancy and Order to Vacate

Dear Property Representative:

Your building was inspected on May 1, 2019, for the reinstatement of the Certificate of Occupancy. On April 2, 2019, the Legislative Hearing Officer granted an extension to May 1, 2019 to get the Fire Certificate of Occupancy reinstated or the property vacated or the property must be vacated by June 1, 2019. Since you have failed to comply with the City Council's reinstatement requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code. A reinspection will be made on June 3, 2019 at 1:00 PM for compliance.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- Basement SPLC 34.10 (2), 34.34(1) Repair and maintain the damaged structural 1. members. This repair requires a building permit, call DSI at (651) 266-8989.-Post jack is sitting on a piece of wood, on top of a concrete block. Another post is half off of a deck block.
- Basement MSFC 603.6 Chimney, smokestacks, or similar devices for conveying 2. smoke or hot gases to the outer air, and the stoves, furnaces, fireboxes, or boilers to which such devices are connected, shall be maintained.-Chimney clean out door is
 - Update 05/01/19: Opening has been sealed with sheet metal and spray foam. There does not appear to be a chimney liner.
- 3. Basement - SPLC 34.10 (1) - Abate and maintain the basement reasonably free from dampness and free of mold and mildew .-

- 4. Front door SPLC 34.09 (4), 34.32 (3) Repair and maintain the door frame. Frame is rotted and sill sags at the bottom. Frame is split where the door latches. Latch receiver is bent.
- 5. Lower front bedroom MSFC 1030.1 Provide and maintain an approved escape window from each sleeping room or area, or discontinue use of area as a sleeping room. This work may require permit(s). Call DSI at (651) 266-8989.-Front bedroom escape windows exit onto an enclosed porch. Large TV is also blocking the windows.
- 8. Multiple locations SPLC 34.09 (4), 34.33 (3) Repair and maintain the window in good condition. -Sashes are rotting, have peeling paint, and do not stay in the open position. Lower unit living room window glass has multiple bullet holes and is broken
- 9. Multiple locations SPLC 34.09 (4), 34.33 (3) -Provide or repair and maintain the window screen.-missing or torn.
- 10. Upper SPLC 34.33 (3) Repair and maintain the door in good condition. -Rear door is split at the latch and deadbolt. When door is closed, can see daylight around it.
- Upper SPLC 34.10 (7), 34.17 (5) Repair and maintain the walls in an approved manner. -Hole behind front door.Update 05/01/19: Hole has been filled, but needs sanding and painting. Filler is still wet.
- 12. SPLC 39.02(c) Complete and sign the smoke detector affidavit and return it to this office.
- 13. SPLC 34.08 (1), 34.32 (1) All exterior property areas shall be maintained free from any accumulation of refuse, garbage or feces.-
