NOTICE OF PUBLIC HEARING

Sound Level Variance Tawfig Islamic Center – Eid-al-Adha

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.</u>

Description of Variance:

Location: 270 Lexington Pkwy. N. – Oxford Community Center.

Noise Source: Oumer M Wako, Executive Director, Tawfiq Islamic Center, has requested a sound level variance, for 80 dBA measured at no specified distance from the sound source, to present amplified sound with use of a sound system for their Eid-al-Adha event on July 19th or 20th, 2021 at 270 Lexington Pkwy. N. The variance is requested for the hours of 6:30 a.m. to 10:30 a.m. on Monday, July 19, or Tuesday 20, 2021 with a pre-event sound check from 6:30 a.m. to 7:00 a.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 7:00 a.m. to 10:30 a.m. on Monday, July 19, or Tuesday 20, 2021 with a pre-event sound check at 7:00 a.m. for the Eid-al-Adha event, at 270 Lexington Pkwy. N. 2) All electronically powered equipment used in conjunction with the event shall not exceed 75 dBA as measured at 50 feet from all sound sources on July 19 or 20, 2021. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 a.m. on July 19 or 20, 2021.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits. Applicant indicates that residents of the block will be given wristbands for their families and friends as part of access and control of number of participants.
