We have gone thru this with the property owner of 2078 Bush in the past when we cut back or remove what is on the city row they leave it to grow back.

I will have a crew available in a couple weeks and we will cut down **ONLY** what is on the City ROW and **NOT** what is on their property. I would expect that as most property owners they would be responsible for maintenance on the Blvd ROW. If they let their trees grow would and reseed into the BLVD they would be responsible to cut back or maintain. This should be explained to the owner.
