## PROFESSIONAL SERVICES AGREEMENT AMENDMENT #1

This amendment serves to augment the Professional Services Agreement ("PSA") between Environmental Initiative, Inc. ("EI"), a Minnesota nonprofit corporation and the City of Saint Paul, a municipal corporation under the laws of the State of Minnesota ("Fleet Operator"), effective April 29, 2021, for repower/replacement equipment approved for funding under the Environmental Protection Agency's ("EPA") Diesel Emission Reduction Act ("DERA") Grants program. This amendment covers the below-listed equipment repowers/replacements until December 31, 2022.

COUNTERPARTS: The parties may sign this Agreement in counterparts, each of which constitutes an original, but all of which together constitute one instrument.

ELECTRONIC SIGNATURES: The parties agree that the electronic signature of a party to the Agreement shall be as valid as an original signature of such party and shall be effective to bind such party to this Agreement. The parties further agree that any document (including this Agreement and any attachments or exhibits to this Agreement) containing, or to which there is affixed, an electronic signature shall be deemed (i) to be "written" or "in writing" (ii) to have been signed and (iii) to constitute a record established and maintained in the ordinary course of business and an original written record when printed from electronic files. For purposes hereof, "electronic signature" also means a manually signed original signature that is then transmitted by any electronic means, including without limitation a faxed version of an original signature or an electronically scanned and transmitted version (e.g. via PDF) of an original signature. Any party's failure to produce the original signature of any electronically transmitted signature shall not affect the enforceability of this Agreement.
