This is to confirm that on June 29, 2021 at the Legislative Hearing, Legislative Hearing Officer Marcia Moermond recommended that the City Council grant to **July 16, 2021 for compliance with the appealed Summary & Vehicle Abatement Orders and Correction Notice** dated April 29, 2021.

Supervisor Lisa Martin will meet you at the property at 10:00 a.m. on July 19, 2021 to verify the vehicles run and look at the property to see if the nuisance conditions are abated.

If you don't wish to contest, no further action is needed.

After the July 14 hearing, a making finding resolution will be scheduled for Tuesday, **July 20, 2021 at 11:00 a.m. via phone** to determine if the nuisance is abated on deadline.
