Good morning.

Thank you for your patience with this property. Mr. Bastel and his property have been one of the most difficult cases I've dealt with in my 23 years working for the City.

I have emailed Mr. Bastel's Social Worker, Mark Eveland, so he can immediately address the racoon issue. Animal Control will be needed to remove them and then all entry points to the home will need to be boarded over. I am waiting for his response and will circle back as soon as I hear from him.

As for the trees, they're normally a civil issue between property owners unless the tree(s) are considered dangerous / nuisance or protruding onto City right-of-way. We will need to inspect the trees to make that determination. I will circle back here as well as soon as that determination is made.

For your information, I'll be sending Mr Bastel a 2nd set of orders that addresses the racoon issue. In the past few weeks I have been in contact with both Mr. Eveland and Chuck's contractor about rehab work and/or demolition on fence, garage and steps, and it sounds as if a plan is coming together for work to start up again here shortly. The deadline to begin work is vastly approaching – July 6th, so hopefully this will happen. But, unfortunately, and as you know all too well, when dealing with Mr. Bastel even the smallest of tasks is nearly impossible to accomplish.

Again, thank you for your continued patience. I will keep everyone posted as soon as I have any info to share.

Good Morning Matt,

We've talked before along with Amy Brendmoen. I'm the neighbor just north of Chuck's house on Victoria. I have a couple concerns (again) that I'd like the city to address.

- 1) There are two trees that are encroaching on my property. One has a branch that is laying on the back of my roof and the other is a dead tree on the north side of Chucks house near the gate to my driveway. Both will eventually fall onto my house and/or car and/or driveway and fence. The damage will be significant. They need to be cut down and/or trimmed away from my property. I've checked with a tree trimming service and the cost is prohibitive for me (over 2K). I'm assuming Chuck does not have a homeowner insurance policy that would cover the damages to my house when the wind or snow bring them down. Due to this encroachment I do need the city to take care of this. I approached Chuck and was quickly told to "get out of here". I understand that the city has already talked to Chuck about his garage, fence and steps on the south side of his house. The issues I have on the north side of his house need to be addressed as well. I'm hoping you will be able to assist.
- 2) There is a family of raccoons (mother and 3 babies) living in Chuck's roof. They go in and out through a hole on the north east corner of his attic. I've attached pictures. I have a dog that spots them every evening and because of the dog they have not come into my yard....yet. I know last year there was work done on his roof line at this spot but evidently, not sufficient to keep the critters out.

I do know this property and Chuck have been a continued "work in progress" and I know Chuck cannot deal with these issues on his own. Please let me know what the city will be addressing or if I have to take this up with other sources.
