Re: Remove or Repair of the Structure at <u>657 Sherburne Avenue</u>

Dear Ms. Tea:

This is to confirm that on July 13, 2021 at the Legislative Hearing, Ms. Moermond recommended laying the matter over to Tuesday, July 27, 2021 via telephone between 10 a.m. and 12:00 p.m. The following items must be submitted by noon on Monday, July 16, 2021:

- 1. post a new \$5,000 performance deposit with the Department of Safety & Inspections;
- 2. submit evidence of financing sufficient to complete the rehabilitation. Previously, staff estimated a cost of \$100,000. If total for bids are more than 20% less than staff estimate, a high level of detail will be required. Financing could be business or personal accounts, a line of credit, or construction loan. Other types of financing will be reviewed on a case by case basis;
- 3. submit a <u>revised</u> work plan, sworn construction statement, or scope of work. This should include **signed** subcontractor bids and a **schedule for completion** of the project;
- 4. The property must be maintained.
