We would also like to address 1) your complaint regarding the price of the garbage hauling service and 2) your request for a temporary service hold for this upcoming winter.

Regarding your complaint about the price of garbage service, we noticed that you currently have medium 64-gal cart. There are service options at a lower quarterly cost. Our lowest services level is a small 35-gal cart with every other week pick up. The cost for this service is \$59.23 per quarter. Please contact your garbage hauler, Republic Services, at **651-286-4590** to change your level of service.
