The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 2:00 p.m. to 10:00 p.m., with a pre-event sound check from 2:00 p.m. to 3:00 p.m., for Let There Be Songs to Phil the Air on Friday, October 1st, 2021 as listed above. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on the date of the event.
