On last Thursday, while working at my dining room table, I noticed Chuck get out of his truck, make his way to the front tree and proceed to take his pants down and remove "PooP" from his pants and butt and place, with his bare hands, under the tree. At this same time children were riding their bikes down the sidewalk.

After he had finished he returned to his truck and peed while sitting on the edge of his truck seat and next to all the garbage that is next to his truck. Shortly there after, his friend Rick drove up and Chuck got in Rick's jeep and they drove off. My son then went over to take a picture of the feces and discovered a pile of old and new. (Picture attached). This is unacceptable gentlemen!!! I am surprised and dismayed that with the many visits you have made to this house you have not noticed, either by inspecting the property or recognizing the odor surrounding Chuck! Also, on Saturday, while talking to his friend Rick, he was screaming that he had a gun and he was going to kill himself. If this is true he has a gun, what will he do with it!
