BLOOMINGTON MN FOA RESPONSE

Those dollar amounts do not contain any Administration Citations. They are comprised mainly of fines that come through the court system, drug and DWI forfeitures, and fines issued from the City Clerk Licensing Division to businesses who sold alcohol or tobacco to under-aged individuals. The fines received through the courts result from violations of the law such as moving violations - for example, speeding or driving without a license.

Here is the breakdown for the two years for those amounts that you inquired about on page 117 of the 2021 Budget Book:

For 2020, the actual amount was \$29,062.83 Number of administrative citations in 2019: 112 total Env. Heal – 87; Building & Inspections – 19; Police – 6
For 2021, the budgeted amount is \$20,000
