Re: Remove or Repair of the Structure at <u>1629 Hartford Avenue</u>

Dear Mr. Sauer:

This is to confirm that on June 15, 2021 Marcia Moermond, Legislative Hearing Officer, stated that at the City Council meeting on July 7, 2021 at 3:30 p.m. she will recommend **they grant an additional 90 days (to October 7, 2021) for the removal or repair of the above-named structure.** Your \$5,000 performance bond will be continued.

At the conclusion of the 90-day grant of time, the Council will receive a report from the Legislative Hearing Officer with findings on the status of the substantial abatement and a Legislative Hearing will be scheduled for **Tuesday**, **October 12**, **2021 at 10:00 am in room 330 of City Hall**, at which owners, interested parties, and Department of Safety and Inspection staff will present information on the current building conditions and progress toward abatement of the dangerous/nuisance conditions. The resulting findings will be presented to the City Council at a public hearing on **Wednesday**, **October 20**, **2021 at 3:30 p.m**. If you wish to attend any of these hearings, you may do so. <u>Please note that these hearings are scheduled to be in person, not via telephone</u>.

Again, the City Council Public Hearing will be **July 7, 2021 between 3:30 p.m. and 5:00 p.m.** If you have further comments and you wish to wish to testify directly to Council and give live testimony remotely at the City Council Public Hearing please contact me at 651-266-8515 or legislativehearings@ci.stpaul.mn.us to let our staff know before noon. If I don't hear from you, I will assume you are not appealing further.
