Dear Mr. Sauer & Owner(s) and/or Interested Party:

Legislative Hearings were conducted in the above-referenced matter before Marcia Moermond, Legislative Hearing Officer, and she recommended that the City Council grant an additional 60 days for the nuisance building to be abated by razing and removal or rehabilitation, as evidenced by issuance of a Certificate of Code Compliance.

There will be a Legislative Hearing scheduled for **Tuesday**, **September 14**, **2021 at 10:00 a.m.** at which DSI staff will present information on the current building conditions and progress toward abatement of the nuisance conditions.

If you received the Certificate of Code Compliance by September 14, 2021, this hearing will be cancelled, and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received the Certificate of Code Compliance by September 14, 2021, please contact Building Inspector Nathan Bruhn at nathan.bruhn@ci.stpaul.mn.us 651-266-9033 to schedule an inspection as soon as you can. Building Inspector Nathan Bruhn will conduct this inspection to determine percentage of completion. The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, September 22, 2021 at 3:30 p.m. At that time before noon, please let us know by calling 651-266-8585 if you wish to appeal further and give live testimony at the City Council.
