Location: 400 Snelling Ave. N. – Amplified sound within the Street and the Beer Garden Area outside of Allianz Field

Noise Source: Zacharia Litzelswope, Director, Events and Guest Experience, has requested two sound level variances, for 95 dBA at no specified distance to present amplified sound with use of a sound system for the MNUFC v LAFC game on Saturday, October 23, 2021 and for the U.S. Women's National Team v South Korea game on Tuesday, October 26, 2021 at 400 Snelling Ave. N- Amplified sound within the Street and the Beer Garden Area outside of Allianz Field. The variances are requested for the hours of 4:30 p.m. to 7:00 p.m. with a pre-event sound check at 3:30 p.m. on October 23, 2021 and on October 26, 2021. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 4:30 p.m. to 7:00 p.m. with a pre-event sound check at 3:30 p.m. on Saturday, October 23, 2021 for the MNUFC v LAFC FC game and on Tuesday, October 26, 2021 for the U.S. Women's National Team v South Korea game. 2) All electronically powered equipment used in conjunction with the events shall not exceed 90 dBA as measured at 50 feet from all sound sources on October 23, 2021 and on October 26, 2021. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:00 p.m. on October 23, 2021 and on October 26, 2021.

Applicant has acknowledged that any social gathering associated with this variance must be managed in full compliance with all applicable Governor Walz and Mayor Carter COVID-19 Orders including but not limited to Orders relating to distancing, mask wearing and attendance limits
