
First, I want to apologize for the delay in this follow up email, as our office had to connect with staff to get some background which took some time.

First, to follow up on your April 6 hearing on 1323 Barclay (File No. J2105E, Assessment No. 218304). Ms. Moermond's recommendation was to reduce the assessment from \$157 to \$77 now. She will also ask the Council to continue public hearing to October 13, 2021, if no same or similar violations, the assessment will be reduced further from \$77 to \$25.

We contacted both Public Works and Forestry staff. I also spoke with Public Works staff who confirmed that the damage to the boulevard is the result of the water service replacement performed by Roto Rooter in February 2018. The contractor, hired by you, is responsible for proper restoration of the boulevard upon completion of their work. Because the work took place in the winter, final restoration could not be completed until the following spring, and apparently

Roto Rooter never came back to finish the job. Since Roto Rooter was under contract by you, the property owner, the you should contact the contractor to come back and finish the work. Below is a picture of the boulevard both before and after the work, for reference.
