Mr. Ostlie,

I'm following up on our conversation this morning. I spoke with the Hearing Officer and she isn't comfortable looking at the matter to consider a further extension right now, **however, please appeal the Vacant Building registration** when you receive it. You can then ask that it is considered a Category 1 Vacant Building (if it is made a Category 2), and that the fee be waived for 90 days (which sounds like should be more than enough time based on our conversation).

Let me know if you have questions, sorry to make you jump through a couple more hoops, but this is the way the hearing officer wanted to handle it.
