Marcia Moermond, Legislative Hearing Officer: This is a registered vacant building fee for 2023-24. The appeal was of the renewal notice. My recommendation is to waive the fee for a period of 90 days. That has 2 impacts: Permits may continue to be pulled even though the fee won't yet be paid and it would directly go to assessment so we could work with it in that context. Mr. Jacobowitch has been working diligently to rehabilitate the property. He estimates that he is halfway there financially, but is hitting roadblocks to complete the financing. He has been referred to local CDCs about possibility for assistance. Not sure what his ask will be. The condemnation was appealed in June of 2022. In the event that he were able to complete the rehab in 90 days there would not be a fee, but we don't anticipate that to be possible. The impact will simply be that permits can continue to be pulled.

David Jacobowitch: I bought the house back in 2000. It was a 100 year old house in poor condition. I've been putting band-aids on it for 20 years. I'm not a rich guy, so I never could get the full renovation that the City would be happy about. In May of 2022 it had a gas leak. We turned off the gas and called the Fire Department. They did an inspection and condemned it. I still needed somewhere to live so I wanted to fix it. I borrowed \$50,000 cash and got a code compliance report. I vacated the building even though it was expensive to find alternative housing. They wouldn't do the code compliance report unless we vacated. I've been going out on a limb financially for the last 13 months. We started doing renovations once the report was done. We assumed that the chimney was good. After putting \$20,000 into new gas piping, furnace, stove, water heater, and all the natural gas work, we found that the chimney had a crack. That was not in the budget. We ended up spending \$12,000 on that last December and got the heat on. That depleted a lot of my funds. I came to the realization that I don't have enough money to complete the project, so I'm stuck. I can't bring it up to code. They won't let me live in it because of that, even though most remaining problems are cosmetic.

Council President Brendmoen: What is your ask?

Jacobowitch: I spent \$40,000 and have about \$15,000 left in the bank. They say it could take \$75,000-\$80,000 total to bring it up to code, so I need to find another \$20,000-25,000. Borrowing money on a condemned house is hard and I haven't been successful. Now, the city hits me with a \$5,000 vacant building fee to put me further in the hole. I'm being financially exhausted. I need the City to waive this fee. I think I can get \$20,000 done. More than that? I don't know.

Councilmember Noecker moved to close the public hearing. Approved 6-0.

Brendmoen: The City doesn't require a certificate of occupancy to be happy. It's to make the home safe. That's the goal. I will move the recommendation of the Legislative Hearing Officer.

Marcia Moermond, Legislative Hearing Officer: This is a special tax assessment related to shoveling of snow on a sidewalk in front of a property. The order to remove the snow and ice was issue February 9. As is practice with these, they issue the order without looking at the site and then send an inspector out to confirm the conditions. If they exist, the inspector will send through a work order. The inspector got there 4 days after the automatically generated letter and found that conditions did exist. The parks crew got there on February 18. I would note that there was no snowfall between the issuance of the order and when the crew arrived. Additionally, there was barely any snowfall in February at all, and you have to go back a week or two into January. The snow in the video I will show you is from January, although the crew showed up on February 18. Also, the appellant did send in additional materials that are attached to the records. Councilmember Balenger did get to review them.

Moermond then showed before and after video from the work crew.

Moermond: The last item I want to put into the record is information on the possibility of salt reducing the thickness of the ice between the issuance of the orders and the time the crew arrived. The temperature readings were pretty high during that time for the effectiveness of salt. They were all well in excess of what's required for salt to be effective at reducing ice so that a shovel can remove the remaining slush. I believe that the property owner would like to address City snow removal on streets as part of the argument. The assessment is \$160 for removal and a \$162 service charge. Total is \$322.

Council President Brendmoen: So the question before us is whether or not the Parks Department cleared the ice covering the sidewalk?

Moermond: Yes. According to the City Charter, the Council would be making its decision based on whether those costs were legitimately incurred by the City and whether that is a true and accurate amount.

Ini Augustine: It is untrue that there was no snowfall in February. According to local data, February saw 2.38 inches of snow and the average snow depth on February 18 was 18 inches. I submitted pictures of what the City did, and the issue seems to be not that I did nothing, but that what I did was not up to standard. This is a case of "laws for thee but not for me." On the day they came out, there was a good 3 inches of ice in front of my home in the street. I attempted to remove it with a pick, shovel, sand, and salt. Today is a historic day of approving reparations for black people. I ask for you to recognize that homeowners of color are being held to higher standards and are targeted for these types of fines. This is a lot of a single mother like me. This could start me on the road to houselessness. I am not a negligent homeowner. They did not need that type of equipment to do this small job, but they did. The costs are unfair and unnecessary. To bypass the dangerous conditions of the streets to reach my small area of sidewalk that had already been done is unfair. It's untrue that there was no precipitation. There was 18 inches of snow still on the ground. To hold me to

a higher standard that the City holds itself to is unfair and unjust. I ask that this fee be waived.

Councilmember Noecker moved to close the public hearing. Approved 6-0.

Brendmoen: Is this a matter where we can spread the payment over 5 years and add to property taxes?
