Amending Chapter 331A of the Saint Paul Legislative Code pertaining to the licensing and regulating of food establishments.

In opposition:

Paula Kennedy (3825 190th Street East, Hastings), owner of Kennedy concessions, confirmed with Council President Lantry that the item dealt with special event licenses, and read a letter expressing concerns about the increase in licensing fees. She said elimination of the annual license and restructuring of fees based on square footage resulted in a fee increase of 500% for her business. She said it was becoming counterproductive for food vendors to operate in St. Paul, and noted that Minneapolis and the state of Minnesota had annual fees for unlimited events and not based on square footage. She said she was confused as to what was driving the increases, and she asked for return to an annual fee. She said businesses would have to pass increases along to customers.

Council President Lantry read from a departmental memo which stated that the changes brought the City into compliance with state law. She said the department had met with a large number of industry representatives who weren't happy with the changes, but now understood why they were being made.

Troy Stuhr (14517 Florissant Path, Apple Valley) said they were caught off guard when they were told they could only do three events in St. Paul. He said they had purchased a second unit as the business started to grow and in anticipation of the opportunity to do more events in St. Paul. He said they were caught up with the required equipment and were licensed by the state, and asked for confirmation that the license for seasonal temporary food stand would take care of them. He said it was his understanding that it was put into place for temporary stands that might just put up a tent. In response to a question from Councilmember Brendmoen he clarified that he believed the proposed new license types would give them what they needed to do more than three events in St. Paul. He echoed the concerns expressed by Ms. Kennedy about the fees.

Councilmember Thune moved to close the public hearing. Yeas - 7 Nays - 0

Daphne Lundstrom, assistant City Attorney representing the Department of Safety and Inspections, said the City could no longer issue an annual special events license, and was replacing it with a seasonal temporary food stand license which allowed a vendor to operate at any one location for up to 21 days as long as state standards were met. She said the fee was not related to square footage, but that was part of the special events license type.

Amending Chapter 66 of the Saint Paul Legislative Code pertaining to RM2 Multifamily Residential density and dimensional standards and amending the Saint Paul zoning map, pertaining to properties along Grand Avenue from Cretin Avenue to just east of Fairview Avenue.

Josh Williams, Planning and Economic Development (PED), gave a Power Point presentation on the development moratorium and zoning study. He said the two recommendations resulting from the study were to adjust RM2 dimensional density standards and to change the commercial nodes to T2 mixed use. He summarized the proposed changes.

Testimony:

Ralph Davies (2014 Grand Avenue) said he was glad the city was taking a look at population density, and he felt the area would benefit from a permanent moratorium. He said an additional problem was that the area had become a Park and Ride for downtown Minneapolis workers.

Brian Fogerty (2166 Lincoln Avenue) said he was asking for a limit of 35 feet or three stories in height and more severe restrictions on density. He said they were already seeing the beginnings of blight on Lincoln since the current construction had begun, and with the current construction at Grand and Finn the block already exceeded the City's desired population density limits. He said neighbors were told by the developer a year ago that the five story, eighty student configuration of the current construction was the minimum density required to make the financials work out, but now the same developer was planning a four story, 48 student building next door. He encouraged the Council to go a little farther on reducing density on those two blocks.

Rachel Westemeier (1935 Summit Avenue), representing the West Summit Neighborhood Advisory Committee (WSNAC), read a statement asking for a mid-block development height limit of 35 feet, and B2 zoning 30-foot height limit at the Grand and Cleveland intersection. She said WSNAC would not take a position on T2 zoning at Grand and Fairview. She read WSNAC's April letter to the Planning Commission.

Rina Cooper (1381 Berry Ridge, Eagan), former Lincoln Avenue resident, said the current zoning wasn't working and she spoke in favor of the proposed changes.

Joel Clemmer (2154 Fairmount Avenue), past president of Macalester Groveland Community Council, said the organization passed motions supporting the study recommendations for both mid-block and commercial intersections, as well as a motion supporting limits on the issuance of parking permits.

Melinda Aljabry (1750 Summit Avenue) said a four or five story apartment building would tower over her backyard, and her privacy was already compromised. She said she was opposed to increasing density and traffic, and felt increased building size would detract from the historical neighborhood feel and affect property values.

Paul Padratzik (1760 Summit Avenue) reiterated concerns about parking demand and said it was only going to get worse. He said he felt the 35-foot height limit was reasonable, and adding two additional stories would be visible from Summit. He said increased density was not necessarily a good thing.

Jeremy Exley, Grand Avenue rental property owner, said the zoning had been there for 30 or 40 years, and the people testifying before him had purchased their homes while that zoning existed. He said community meetings were during the day and he

was unable to attend. He said the students were already there and the buildings did not increase density. He said the buildings would bring students out of the neighborhoods and closer to campus.

Ed Martell (2149 Goodrich Avenue) said they had worked with St. Thomas on problems they used to have to deal with, and changes had been made. He said he was a member of WSNAC and agreed with their opinions, and felt neighborhood balance was key: between neighbors, St. Thomas, developers, and the City. He said it was better and less costly to be proactive rather than reactive. He said it would be nice to see the impact of the first building before the second was built, and he spoke about the effect of having a dorm in a residential neighborhood.

John Hershey, representing St. Thomas, said St. Thomas was an active participant in the zoning study and all of the hearings, and had elected to take no formal position. He said there were no immediate plans to build on-campus housing, and they anticipated modest if any enrollment growth over the next few years. He said they would continue to work with the neighbors and the City.

Councilmember Stark moved to close the public hearing Yeas - 7 Nays - 0

Councilmember Stark thanked everyone for their testimony. He said trying to balance the competing needs of different groups made it a complex issue, but he felt the Planning Commission had done a good job of finding a middle ground. He said the desire to keep density down had to be balanced with practicality, and the City also had a general interest in growing density along commercial corridors. He said in the long term it would be nice if St. Thomas could find a way to house more students on campus. He said the fourth reading and vote were the following week, and he supported the recommendations of the Planning Commission.
