Michael Solomon, Office of Financial Services Debt Manager, gave a staff report on the bond sales that had taken place that morning. He said the City bond ratings had been reaffirmed at AAA by Standard and Poor, and Fitch, and those top notch ratings and favorable market conditions resulted in a positive outcome for the sales. He summarized the outcome of the sales.

He summarized the results of the sale. He thanked City Finance and Public Works staff; financial advisor, Springsted; and the bond counsel, Barnes and Thornburg.
