Council President Stark said since the public hearing his office had been in close communications with public works and had sent notices to neighbors with the mitigation strategies discussed at the public hearing

Luke Hanson, Public Works, reviewed the resolution and amendment made on August 17, and gave a staff report on proposed mitigation strategies. He said staff recommended implementing bike lanes on Hamline from Minnehaha to Pierce Butler, including mitigation strategies, in 2017.

Two residents present in the chambers tried to ask questions. Council President Stark said he would answer questions following the meeting. In response to one question he said the work would be completed in the summer or fall 2017.

Councilmember Prince said she appreciated that there had been some mitigation for areas where parking was lost but was concerned that accommodation was being provided only for half of what the parking demand had been. She said, as Councilmember Brendmoen had said in the past, this was a matter of paint on the street and it could be revisited if necessary. She said she had a real problem with removing parking where people didn't have other options, particularly where businesses were losing parking. he said she wanted to assure neighbors that the Council was listening and would keep track of how this was working.

## ORDINANCES
