Ms. Ashley: where my property line ends, there's a dead alley (has photos); the man in the back just throws everything back there; for me, to go thru a wooded area in 4 feet of snow & drag a mattress & garbage back there is preposterous; I'm with Krupenny Garbage; we pay enough money - they take anything - all of our furniture; so, there's no reason for us putting anything back there

-when that notice came, I was throwing out a couch & Krupenny did pick up the couch; that's where the confusion came

-you'll see that this is no alley

VIDEO - city crew picked up mattress

Ms. Moermond: that is on your property though, isn't it?

Ms. Ashley: I don't even go back that far; I can show you on my pictures.....

Ms. Moermond: so, the fence line goes beyond your property line

Ms. Ashley: brought up her photos & tried to explain the back of her house & the wooded area on her property where the mattress was dumped by the man who lives behind her

Ms. Moermond: I don't have a fence line or any other point of reference when I look at that photo

-you were sent a Notice to clean up the mattress; it's on your property

-reviewed the "after" Video again

-have you considered clearing out the brush in the dead alley?

Ms. Ashley: it's the end of a dead alley; can I show you more pictures of what's all back there in that dead alley?

Ms. Moermond: I think it's more affective to send an inspector out there to write Orders on things that are in the alley if it's on other people's property as a dumping area because I can look at the pictures but I don't have the ability to take action on an item; they do

Ms. Ashley: I think it's unfair because this is a dumping ground

Ms. Moermond: it appears to be something that's dumped; I think that you need to take some proactive steps - get rid of that brush & possibly put in a fence; some people use motion detector lighting; it looks like an unkempt & unwatched area with that overgrown brush & it's your property & your responsibility

Ms. Martin: call 266-8989 & give the addresses of all the other properties along that dead alley where dumped items are located; if we haven't already been there, we'll go out & take a look

Ms. Ashley: so, you want them to shoot my house up?

Ms. Martin: they won't know who called it in

*Ms. Ashley: they'll automatically know because I'm the one who's been raising hell about people dumping stuff back there; I'm not going to put my life at risk
-I'm just trying to say that it's unfair that I'm getting the assessment
-I'm the one who went back to the neighbor & just had it out with him*

*Ms. Moermond: EMK should look at clearing out the brush there & take responsibility
-you don't have a history here but you did get Noticed & more than a week to deal with it
-will recommend approval*

History of Orders on Property: 8 complts in 2017 but all abated

*Ms. Blodgett: a neighbor complained about my walk because of personal issues between him & me that I won't go into; I got the Notice & immediately called; I was told that I should shovel my walk again, which I did; I explained that to Mark, who was very sympathetic & understanding; I'm a runner & when I run, I always want to stay on the sidewalks that have a very thin cover of snow on them because with the freeze/thaw cycles that we have now, if you keep you keep your walk down to the absolute concrete, then, when it melts, it freezes & you can't see the ice, slip & fall; so, I have a very methodical way of doing my walk that is safe for everyone; my next door neighbor has the most dangerous walk on the block & I see people day after day avoid his walk because it's so perfectly manicured that there's always an ice cover on it, which you can't see; I explained this all to the inspector, who said he totally agreed & that we now have a new problem -then, there was the timing problem of when I called & he said
VIDEO - sidewalk with a very thin layer of snow to make walking/running more safe; city salted & sanded*

Ms. Moermond: I do understand why the crew was dispatched; looking at this photo, there's 2-3 inches more than what I'm looking at

Ms. Blodgett: it had just snowed

Ms. Moermond: no; actually, it hadn't; there was almost 1 inch that fell on the 19-20th but otherwise, there hadn't been anything since way before the Order was issued on Feb 12; there was no snow at all until .8 inches on the 19th & .3 inches on the 20th; at the same time, when the crew showed up, it was cleared; so, for future reference, we need to get it down faster than the 9 days but because what I looked at was cleared, I'm comfortable recommending this gets deleted

Ms. Vang: my understanding is that the Notice was sent Jan 25, 2018; at that time, a Purchase Agreement was in place; Moua Vang was the buyer; title work was done Jan 29; there were no pending assessments of any sort outstanding; the city did the work on Feb 1, 2018; my client closed on the property Feb 9, 2018; there's no way that we would know about this Order

Ms. Moermond: the only way you would know is if the seller disclosed that this Order was in place, which is incumbent upon the seller; did you ask the seller if there were pending Orders on the property?

Ms. Vang: we didn't get a chance to ask the seller; the seller was out of state; he had signed the document but they didn't tell us about anything about an assessment

Ms. Moermond: this is a 24-hour Order

Ms. Seeley: once the letter goes out, we wait 3 days (courtesy delay)

VIDEO - city crew removed the snow; salted & sanded

Ms. Moermond: the Order went to the previous owner; there was no disclosure; a lot of work was done by the city; I suggest you seek recompence from the seller;

Ms. Vang: seller is out of state; don't even know if he got the Notice; we took care of the snow in the driveway

*Ms. Moermond: there was a 12-inch snowfall 3 days before the Order even went out; the crew showed up 10 days later so, there was no effort by the seller at all to address the problem & a real nuisance condition did exist; the mail went to the owner's address of record, which was 594 Earl Street
-so, I'm stuck; I advise you to seek out the seller & try to get reimbursed for this assessment*

Ms. Vang: and if he refuses to pay?

*Ms. Moermond: then, you can file a claim in Small Claims' Court; they did sign a closing agreement that did say that they were disclosing this information to you & clearly, they did not; that's a private matter between you & the seller
-this was ordered for the previous owner to do; he didn't do it but he sold you a property with an assessment on it; they didn't tell you that - bad on them but when you buy a property, you also buy the property's debt*

Ms. Vang: my clients don't want to go thru the process of going after the seller; they have agreed to pay the assessment

*Ms. Moermond: OK; I suggest you contact the seller's realtor & handle this professionally
-will recommend approval; it's a private matter now

Mr. Johnson: I actually snow blowed the entire area; we live on a high volume street area; where they show the snow has piled up, that from the city snow plow comes by & throws it back onto the sidewalk; I have video/pictures of each time it snowed, before & after my snow blowing; we also shoveled, salted & sanded; we can prove it; we were the first ones done on our block on Jan 22 (he showed the pictures); Ms. Moermond asked that he forward the photos to her

Ms. Johnson: we've been getting letters about the snow so, I told my husband to start taking photos & videos of our snow efforts; the side walks are clear but when the plow comes thru, it throws the snow right back onto the corner

Ms. Moermond: it appears that you were on top of it but not on the corner situation; people need to navigate there to get through; asked to have all the dated photos emailed to her

Ms. Seeley: there's a forthcoming assessment; on May 23, 2017, there were Orders on garbage; on Dec 7, 2017, Orders on garbage & vehicles

Mr. Johnson: all of those were abated & every time an inspector came, I was there

Ms. Moermond: asked to see the "before" VIDEO one more time

Mr. Johnson: in 2017, we reclaimed this home

Ms. Moermond: is the house on Thompson in West St. Paul a rental now that you're owner-occupying Lexington or ...?

Mr. Pylkas: we turned it into SPPD when we had the problem that you just saw on Video; in fact, we turned in the description of the car; license plate # & an eye witness description of the dumper; nothing happened; SPPD called me back & said that the car's title had been changed; they couldn't trace the new owner & they thought that the man who owned the car was black; the man my tenant witnessed dumping the trash you saw; notice that the dumpster itself is relatively empty; that's because when I was notified I had them go out & dump the dumpster

Ms. Moermond: it was clear to me from the Video that the dumpster was half full of garbage bags that were obviously from the tenants who use the dumpster & that the problem was the area surrounding the dumpster... and that's why it's important to hear what is described in the Order.... in the Video I saw a mattress & a couch, not mentioned in the Order

-Org Order issued Fri, Feb 16 & cleanup was Feb 28, a 1 1/2 weeks later

Mr. Pylkas: garbage service comes every single Mon morning - like clockwork; they empty the dumpster only

Ms. Moermond: so, there would have been 2 Mon mornings

Mr. Pylkas: since you saw that Video, I have increased the size of the dumpster to a 5-yard dumpster; beyond a shadow of a doubt, I know that I am the neighborhood dump

-there are 6 recycle cans up against my fence; I never ordered those cans; I have no idea why they're there; I try to remove them & they come back; it's an open invitation to use that dumpster as the neighborhood dump; in the 17 years that I've owned this property, we've turned in over 30 people; not one has been prosecuted; not a single person; so, I've just accepted the fact that I am the neighborhood dump & I have a man who goes out & cleans that up for us; I'm positive that on Feb 16, I called Highland & asked them to dump the dumpster & I also called Doug ____, the guy who works for me, who does that kind of thing; he may not have gotten to it quickly especially, if we also had snow during that time because he's also responsible for snow removal

-you usually don't hear from me because I simply take care of these matters; & if I do get a letter, I'll call & if there's any debris that the city wants picked up, we get it out of there & we've done that for 17 years

-I don't know how we got caught in this mess

-I have a snapshot camera & lights there

-SPPD isn't going to spend the time/effort to chase this kind of thing down

Ms. Moermond: I'm comfortable recommending that this gets deleted given that you worked with the police on this; I think the situation might change for you when organized collection is implemented where everyone has garbage service, which will remove the need for people to dump if they're not able/willing to pay for garbage service on their own
