1 RLH RR 19-3

Ordering the rehabilitation or razing and removal of the structures at 899 GERMAIN STREET within fifteen (15) days after the February 13, 2019, City Council Public Hearing. (To be referred back to Legislative Hearing on March 12)

Sponsors: Busuri

Layover to April 9 provided owner posts a \$5,000 performance deposit by close of business on Friday, March 29. If the condition is met, Ms. Moermond is looking for the following conditions to be presented on or before April 9:

- 1. provide a signed contract between the parties for the rehabilitation of the property;
- 2. a detailed work plan or sworn construction statement, with timelines, for the completion of the rehab of the building in accordance with the Code Compliance Report;
- 3. must submit bids from general contractor and subcontractors;
- 4. provide documentation of financing sufficient to execute the above work plan (line of credit, construction loan or personal bank account). The City estimates the cost to repair to be \$50,000; however, this number is likely to change on estimates owner/purchaser brings forward;
- 5) If funds being used is from a personal account, must provide an affidavit stating the necessary funds will be set aside for the rehab; and
- 6) the property must be maintained.
