Staff report by Chris Swanson: resident is here for \$100.48, garbage for medium cart and 3 late fees Quarter 1, 2019. Doesn't want to use the program and doesn't believe it was implemented correctly. Staff believes assessment should stand. Resident was here for Quarter 4 in May too.

Ms. Moermond: Ms. Lacey appeared on mother's behalf for that quarter. You talked about location difficulties then, neighbors were taken advantage of it, and you used to take your garbage to a commercial property you work with. We also talked about decreasing cart size. Did anything happen with that?

Ms. Buckner: no. I don't agree because I am not using the service. I have two commercial dumpsters at other properties and put it in there. Even if it was free, I wouldn't use it. I have to pay for the dumpsters regardless. My bill is paid because I pay through my business. They haven't picked up a toothpick from me. I had a meeting myself with a bunch of seniors to see how they felt, to my surprise a whole lot liked it. It's convenient for them, I told them my complaint. The corner property, the garage goes right up to the alley. The yard and garage goes right up to alley line, if they put the cans back there we don't go back into the alley to see them. I hate the fact that the service I'm not using going in my taxes. If I had some extra money to give away I'd rather use that money to feed a single mom and her kids. It's about time for city government to stop forcing us to do what we don't want.

Ms. Moermond: Ms. Lacey probably told you that I don't have a lot of latitude on this. I'm going off the codes the City currently has. Right now under the codes and contract, all properties of your type are in the program. There's no opt out, that's the way it's set up. I don't have a way to get you out, I hear a lot of people with your argument. I'd like to get your bill lower so even if you lose your bet, you'll be out less money. I know you disagree with the service, that at least lowers the amount if you don't prevail. Is that something you want to do?

Ms. Diana Chao: you have the medium cart. The smallest cart is 35 gallon and that is \$63.08 a quarter.

Ms. Bucker: but I'm not going to use the can.

Ms. Moermond: I understand that, but that isn't something I can get you out of.

Ms. Buckner: if I go to the smaller size I'm still giving money for service not rendered. What do I get for that, do I get a bonus for the donation I'm making?

Ms. Moermond: whether you choose to use the service or not, you are in the program. I'm trying to help you minimize the impact. I can't get you out or say you get a prize because you don't use it. All I can say is I can help you get your bill the smallest it can.

Ms. Buckner: yes, I want the smallest you've got. I will keep arguing until this is removed from my taxes. I don't want to give people my money.

Ms. Moermond: Mr. Swanson can you process the cart size change. What is the date for service?

Mr. Swanson: Thursday

Ms. Moermond: if you put out the cart next Wednesday they are going to change it out from a medium cart to a smaller size with a purple lid. If for some reason in the future you aren't able to get to the church or your business, you can have free walk up service to get the cart emptied. I will decrease this bill and Q2 bill to be the smallest cart size.

Staff report by Mr. Swanson: Assessment for \$105. 68, medium cart and two late fees, Quarter 1, 2019. Resident is appealing because the submitted to the City and to Republic multiple times that even thought this property is a duplex, no second cart has ever been dropped off since program started. There is still not one at the property. City records show one 64 gallon medium cart and one 96 gallon large cart delivered on September 13, 2018. According to Republic information the property owner stated he did not want the second cart, we haven't received any phone calls from the resident on vacancies or not having second cart.

Ms. Moermond: There's also a comment about Republic saying the owner told them he didn't want the second cart?

Mr. Swanson: yes, Republic stated that from an email on Tuesday that the resident called into them and that they didn't want the second container and Republic told him he needed to keep it.

Ms. Moermond: did Republic say when this occurred?

Mr. Swanson: they didn't give specifics on when.

PO: the can that is there is the large size and that's a 90 gallon.

Mr. Holbrook: the can there is the large size.

Ms. Moermond: do you have information to share? I'm looking at the notice of non-payment from March 31, a document dated April 15 which is already in the record, bill due April 25 with current charges, and another notice of non-payment dated January 31. The new pieces are the 2 invoices.

Mr. Holbrook: as I have stated, there has never been as second cart at this property. The history is when I got the bill for Quarter 1, I called Republic, that was the April bill, and they took the second cart charges off. You'll see credits for a nonexistent cart. I paid that invoice, and then received notice of the \$105 or \$111 amount is. I did get a letter from Republic 60 days ago saying a duplex had to have a second cart, they instructed me to call to have a second one dropped off. I don't intend to call. My taxes shouldn't have a charge for a can they have never provided.

Ms. Meormond: when did you communicate you didn't want a second one?

Mr. Holbrook: every time, I've called 3 to 4 times, letters.

Ms. Moermond: we have one letter dated April 15, but we're talking about the first

quarter. It appears two were delivered, I have pin numbers. One is missing, we don't know why. Mr. Swanson, how do we handle it when carts go missing?

Mr. Swanson: first I want to get information from Republic of having 2 carts out at the property. I'd like to give him a pin so he can look around at his neighbors for this cart.

Mr. Holbrook: I'm not going to go up and down looking at my neighbor's carts.

Ms. Moermond: you don't want to do it because you don't want the second cart. I'd like to get the bill as small as it can be. You're going to have a bill and have 2 carts. Go with a small can for each of the units, to minimize the impact of the bill. If you're going to have two, you would have 4 bulky items. You get two per unit. With the larger cart size you'd have 6. That's the only difference besides cost. I'm going to review the invoice. I have April and January invoices before, I'm inclined to split the difference on the second cart. We'd pick up the current cart to change out and get two small carts. Do you want to do that?

Mr. Holbrook: yes, I guess that's my best option.

Ms. Moermond: I will review that and take your willingness to change size into consideration. Because we have people waiting I'm not going to walk through the math here. So we will send you an email and I can get back to you.

Ms. Chao: do you want one small every week or every other week?

Mr. Holbrook: one of each. One small weekly, one small every other week.

Staff report from Diana Chao: pending assessment is \$299.36 for Quarter 1, 2019, he thinks that Highland sanitation is charging for extra bags. The property owner has contacted both Highland sanitation and City who have both sent him documentation and pictures of the extra bags. So staff does believe he's responsible for the delinquent bill.

Ms. Moermond: I see snow in the pictures, I know there was some time when haulers had time to get down the alleys and can't service but will come back next week and not charge for extra bags. Did that happen here?

Ms. Chao: with Highland they just pushed it one day back, so no impact that way.

Ms. Moermond: this looks like a duplex?

Mr. Nguyen: it is. I don't dispute the monthly or quarterly payment, we paid for that, I'm just disputing the bags. You look at the picture; they seem to charge me more than 10

bags on the one invoice. What is the size of bag that would assess the \$3 for each bag?

Ms. Chao: it's not a size, if your cart is open over 6" they will count the additional bags.

Ms. Moermond: let's bring up the photos on the screen. Looking at these, the first photo is dated March 28, 2019.

Ms. Chao: these photos bags would show up on Quarter 2 bill. We want Quarter 1 photos.

Ms. Moermond: they gave you 7 photos but none from the fourth quarter. Is this because they weren't any photos?

Ms. Moermond: we can ask them. But I also want to look at the bill because it doesn't make sense. I want to add up the bags. If I add up the extra bag fees with taxes, it would only be \$157.04. Did you pay in January \$192.16?

Mr. Nguyen: no, in February.

Ms. Chao: Ok so with tax its \$232.80. We need pictures from the dates listed here from Highland.

Ms. Moermond: and I would want to look at them too. I wanted to look at the Quarter 1 photos to get a sense of how they're charging these out. For this photo they want to charge \$3, the March 28 photo. I think there's something propping that one up. Looking at March 7, I'm ok with that charge for 4 extra bags. February 1 they are saying four extra bags for \$12, I see a lot there. These are medium carts?

Ms. Chao: yes, 64 gallon.

Ms. Moermond: well, *Mr.* Nguyen and we had so only pictures of quarter 1, not of quarter 4. Those charges are next time. I wish they would have sent the right photos. We're going to ask them to do that. Right now, it seems clear to me you need a different size can.

Mr. Nguyen: I did that, starting second quarter. I want to see the pictures. My issue is I am getting charged \$3 whether it's one small grocery bag, or one large 55 gallon.

Ms. Chao: the contract is just number of bags.

Ms. Moermond: I think a bathroom size garbage bag vs. a kitchen size bag. When we get the photos we can look at that. We can all look at them together, or I can send an email to you with an assessment on how I see those.

Mr. Nguyen: I'm fine with getting an email, then if I don't like that I will go forward with the hearing. That's fine.

Mr. Tarose: it's my recollection that I've paid those fees. At that point, with this last statement there was no late fee or nothing.

Mr. Swanson: it does look like they're undercharging you for two carts.

Mr. Tarose: yes my bill increased from \$147 to \$195.

Mr. Swanson: what happened is they were charging residents with 2 or more carts for 1 cart and an extra cart, and they should have been charging for 2 carts. They did just adjust this per the contract, they had been undercharging you. \$45 less for the last 3 quarters.

Mr. Tarose: they gave me credit to help readjust that; I saw no proof or nothing. It is a duplex.

Ms. Moermond: right now they're saying there's the \$22.09 late fee. You are saying you have paid. If you want to send that information in, we're happy to look at it. Right now I recommend approval and do an \$11 late fee.

Ms. Moermond: we would be looking at a fee of \$146.49 and that's not a traditional amount of money. It seems like it may be one of those strange charging thing with the two carts.

Mr. Swanson: they were likely charging for a cart at the base rate and then an additional cart fee, not the base rate fee.

Ms. Moermond: Republic was billing incorrectly on duplexes, for \$45 less than they should have been. They were charging for one cart, full price, and second cart half

price. They're eating that cost.

Mr. Mattie: I don't think that's what happened here. I asked for base service every 2 weeks in October 10. And billing would take 2 weeks to change. And it didn't happen for a long time. Eventually I did get the right cart in March or April. They charged me too much, because I'd asked for the lower service early, and they weren't responsive to my concerns.

Mr. Swanson: so the haulers were not exchanging carts in Quarter 4, 2018, we wanted to make sure people had carts.

Mr. Mattie: I wasn't expecting it right away, it took a long time.

Mr. Swanson: you were supposed to be paying the Quarter 1 bill and then you'd have a credit going forward.

Mr. Mattie: I don't know when the physical carts got changed, it was sometime in Quarter 2.

Ms. Moermond: that seems like a time lag from October 10, they should have had done it in the New Year.

Mr. Swanson: they weren't taking formal requests until a cart swap was allowed in January. So that's why if you called in October, they wouldn't have a record of the cart swap.

Ms. Moermond: how would the person know that ?

Mr. Swanson: the haulers should have been saying that, to call back in January. We have record of a small every other week cart and a medium cart at the start of the program.

Mr. Mattie: my tenant didn't respond so that was the default size.

Ms. Moermond: is there a second quarter issue?

Mr. Swanson: I don't see one.

Ms. Moermond: I'm calling this a growing pain, I recommend the amount be deleted.
