Authorization to acquire tax forfeited parcel 53 Geranium Avenue W. and convey to Greater Frogtown Community Development Corporation; to acquire 722 Lafond Avenue, 762 Thomas Avenue, 1025 Seminary Avenue W. and 466 Iglehart Avenue and convey to Twin Cities Habitat for Humanity, Inc.; to acquire 995 Rose Avenue E., 615 Maryland Avenue E. and 486 Victoria Avenue S. and convey to Singular Development Resources Inc. Districts 5, 6, 7, 8 and 9, Wards 1, 2, 5, and 6

Dr. Bruce Corrie, HRA Executive Director, stated that out of the 23 forfeited properties we were notified in November 2017, 8 were requested by developers/partners for acquisition. One of them, the partnership ESNDG/Singular, has released 1545 Etna Street after further consideration of the purchase price and development costs. For all of these projects, the developer must provide its own financing for the project and be willing to complete the project within the time period required. The developer must sell the property to a qualified end buyer and the ownership must remain affordable for 7 years.
