Stated Reason for Appeal (if given): Property had a fire and the property has been vacant since February 2017. Property is currently under construction and contractor is using own dumpsters.

Staff Comments: Property owner had not completed an unoccupied dwelling registration form. Given that there was a fire at the property and it was uninhabitable, it should have been on the city's vacancy list.
