**Staff Comments**: Billing records from Waste Management show that the property owner was being billed for both 6/1/2022 - 12/31/2022 and 1/1/2023 - 3/31/2023 on their Quarter 1 2023 invoice. Since haulers are unable to collect for previous billing periods, and there was a service hold in place during Quarter 1 2023, staff recommends removing the assessment in full.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services during January to March 2023.
