Stated Reason for Appeal (if given): Resident submitted an Unoccupied Dwelling Registration form to the city in July of 2019 for one of the residential dwelling units. The vacancy update was sent to Waste Management with the 7-19-19 Hauler Update List. They also requested a cart switch in July from a medium 64 -gallon cart to a small 35-gallon every other week cart in July.

Staff Comments: Staff confirmed with hauler that resident has submitted an Unoccupied Dwelling Registration form to the city in July of 2019, as well as reuested a cart swap from a medium 64-gallon cart to a 35-gallon every other week cart in July 2019. Therefore, staff recommends reducing the assessment to the cost of a small 35-gallon every other week cart (\$60.83).
