Authorizing the City to transfer \$6,061,828 in CDBG-CV funds to specific accounts for COVID related activities.

WHEREAS, the City of Saint Paul is an entitlement grantee that receives direct funding from the United States Department of Housing and Urban Development (HUD) for the following programs: Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and Home Investment Partnership (HOME); and

WHEREAS, Congress passed the Corona Aid, Relief, and Economic Security Act (CARES Act) on March 27, 2020 in response to the coronavirus (COVID-19) pandemic; and

WHEREAS, on April 2, 2020, the City of Saint Paul as an entitlement grantee was awarded a special allocation of \$4,054,659 in CDBG-CV funding through HUD under the CARES Act based on the fiscal year 2020 CDBG formula to prevent, prepare for, and respond to COVID-19; and

WHEREAS, on September 11, 2020, the City of Saint Paul as an entitlement grantee was awarded another special allocation of \$2,007,169 in CDBG-CV funding through HUD under the CARES Act at the discretion of the Secretary of HUD to prevent, prepare for, and respond to COVID-19; and

WHEREAS, these funds must meet all of the CDBG program requirements unless specifically waived under the CARES Act including meeting one of three national objectives: benefitting low- and moderate- income persons, preventing or eliminating slums or blight, or meeting other community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community and other financial resources are not available to meet such needs,

WHEREAS, pursuant to the CARES Act, these CDBG-CV funds must address impacts to residents and businesses from the COVID-19 Coronavirus Pandemic.

WHEREAS, on December 9th, via resolution 20-278, the City accepted these grants and amended the 2020 federal grants budget and increased the CDBG grant budget by \$6,061,828; and

WHEREAS, the City has identified the following activities, that are consistent with CDBG program

requirements, to prevent, prepare for, and respond to COVID-19 for a total of ~~\$5,091,828~~\$6,061,828:

- Expanded Meal Access: \$675,000
 - Mobile Library Services: \$312,920
 - Career Labs: \$635,325
 - Library Materials Hold Lockers: \$232,500
 - FAMILY Distance Learning: \$620,00
 - COVID Reporting: \$15,000
 - Unsheltered Meal Support” \$1,157,000
 - Expanded Contract with SMRLS: \$50,000
 - ~~Fire Station 51 Acquisition: \$970,000~~
 - Business support: \$182,255
 - Program Administration: \$1,211,828
-
- A subsequent budget action will be taken on the balance of \$970,000.

WHEREAS, pursuant to Section 10.07.4 of the Charter of the City of Saint Paul, the Mayor recommends the transfer of the unencumbered CDBG-CV funds to the project activity codes as outlined in the attached financial analysis; now

THEREFORE BE IT RESOLVED, by the Council of the City of Saint Paul, does hereby authorized the City to transfer ~~\$5,091,828~~\$6,061,828 from the federal grants budget CDBG-CV holding account to the project activity codes as outlined in the attached financial analysis.
