Stated Reason for Appeal (if given): Property owner passed away 9/7/2018 and the house has been vacant since. There has been no trash collection at the property. Was set up for vacancy in 2019. Provided death certificate for Larry.

Staff Comments: The City received notice of vacancy on 1/29/19. This vacancy hold started on 2/1/19. Because the City did not receive notice of a vacancy prior to 1/29/19, garbage service was not removed for the property. Garbage service was provided from October through December 2018.
