Stated Reason for Appeal (if given): I built my house in 1994 and have never ever paid for garbage removal due to an agreement with relatives who own a trash company. I cannot afford to pay for trash removal. This system was never broken and the change is unnecessary.

Staff Comments: Under citywide garbage service, all residential properties with up to four units, including rental homes and townhomes, are required to have a garbage cart and receive garbage service for each dwelling unit. Property owners must provide garbage service for all occupied dwellings. There is no option to opt out of the citywide garbage service. The property owner is responsible for paying the outstanding charge, as garbage service was provided from October through December 2018. The property owner is currently using a 35-gallon Small Weekly Cart. The City can help the property owner coordinate a switch to the 35-gallon Small Every Other Week cart if the property owner would like to decrease their service level and garbage bill cost.
