**Staff Comments**: During the legislative hearing held on 7/25/19, the legislative hearing officer recommended to reduce the pending assessments for Quarter 4 2018, Quarter 1 2019, and Quarter 2 2019 to the price of 1 35-g Every Other Week cart, which is \$60.83, if the property owner changed their cart from the 64-g to the 35-g Every Other Week. Waste Management scheduled this cart swap. Quarter 4 2018 and Quarter 2 2019 were reduced already. This amount for Quarter 1 2019 is to be reduced to \$60.83 during the upcoming City Council Public Hearing on 11/13/19.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for services during January to March 2019.
