**Stated Reason for Appeal (if given):** i have hauling service from Aspen at 544 Ohio which costs me \$103.55 for 9 units including the 542 building. City wants me to add another hauler at \$249.68 per month. Republic agreed to pick up dumpster and didn't do so. Dumpsters have been removed from premises so there is no place for them to pick up. Republic charges me \$126.20 to haul for a 12 unit in South St. Paul. To communicate with Republic sometimes takes 45 minutes waiting on the phone

**Staff Comments:** Under citywide garbage service, all residential properties with up to four units, including rental homes and townhomes, are required to have a garbage cart and receive garbage service for each dwelling unit. Property owners must provide garbage service for all occupied dwellings. There is no option to opt out of the citywide garbage service. The City is operating under a signed contract under state statute.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Trash Hauling during Collection of Delinquent Garbage Bills for services during October to December 2018. WHEREAS, the City Council's Legislative Hearing Officer has reviewed an appeal of this assessment and developed a recommendation for the City Council with respect to this assessment; and
