**Stated Reason for Appeal (if given):** Haven't had garbage service since October and doesn't have a City garbage cart. Received a cart but called to cancel and had the cart taken away. Takes garbage to transfer station.

**Staff Comments**: Under citywide garbage service, all residential properties with up to four units are required to have a garbage cart and receive garbage service for each dwelling unit. There is no option to opt out of the citywide garbage service.
