**Stated Reason for Appeal (if given):** I stopped my trash service by calling Republic for the Oct.2018 thru April 2019 trash service period. I was in Seattle most of the time..I did not use trash pick up during those months.

**Staff Comments:** Republic Services confirmed that they removed the garbage cart from this property on 11/21/18 and did not provide service during Quarter 2 2019. Staff recommends deleting the assessment.
