WHEREAS, in the matter of the appeal of Richard H. Nicholson to a Correction Notice at 260 SUMMIT AVENUE, the Legislative Hearing Officer has reviewed the appeal and considered the testimony of City staff and the appellant;

WHEREAS, the Legislative Hearing Officer recommends that the City Council deny the appeal and grant an extension to October 31, 2011 to repair the wall; Now, Therefore, Be It
