Resolution accepting additional grants of \$1,325 from the Saint Paul & Minnesota Foundation and amending the 2020 Housing and Redevelopment Authority budget, Citywide

WHEREAS, on April 1, 2020 the Housing and Redevelopment Authority (the "HRA") Board of Commissioners approved RES 20-597, authorizing the guidelines for the Saint Paul Bridge Fund for Families and Small Businesses (the "Bridge Fund") and allocating \$3.3 million of HRA resources to fund the Bridge Fund to provide emergency relief to small businesses and families in response to the economic impacts of the COVID-19 pandemic; Citywide; and

WHEREAS, Mayor Melvin Carter launched a private donation campaign in partnership with the Saint Paul & Minnesota Foundation to support families and small businesses most vulnerable to the economic impacts of COVID-19; and

WHEREAS, on April 22, 2020 the HRA Board of Commissioners approved RES 20-666, accepting \$747,980 from the Saint Paul & Minnesota Foundation for the Saint Paul Bridge Fund; and

WHEREAS, on May 27, 2020 the HRA Board of Commissioners approved RES 20-789, authorizing up to \$115,000 of additional private donations from the Saint Paul & Minnesota Foundation for the Saint Paul Bridge Fund; and

WHEREAS, generous private donations from philanthropy, corporations, and individuals ultimately contributed an additional \$1,325 to the Saint Paul & Minnesota Foundation to benefit Saint Paul families and small businesses through the Saint Paul Bridge Fund; and

WHEREAS, by this Resolution, the HRA Board of Commissioners accepts and receives the additional \$1,325 private donations received by the Saint Paul & Minnesota Foundation and amends the 2020 HRA Budget.

NOW, THEREFORE BE IT RESOLVED, by the HRA Board of Commissioners, as follows:

1. The HRA Board of Commissioners hereby accepts and receives the Grant Funds from the Saint Paul & Minnesota Foundations.
