Stated Reason for Appeal (if given): Property owner stated that they purchased the property in February 2020 and called Advanced Disposal to update the name and mailing address on the account. However, they did not receive a Q2 2020 invoice as it was sent to the mailing address of the previous owner.

Staff Comments: Staff confirmed that the invoice had been sent to the mailing address of the former property owner. Therefore staff recommends removing the late fees and reducing the assessment to \$93.07. Staff is currently investigating why Advanced Disposal charged service rates that were from 2019.

WHEREAS, the Office of Financial Services Real Estate Section has attached to this Council File both a report of completion outlining the costs and fees associated with Collection of Delinquent Garbage Bills for service during April to June 2020.
