**Stated Reason for Appeal (if given):** I am inquiring on file number CG2001C3 Assessment #200110 property address 1905 Minnehaha Ave. E. I have concerns with this assessment because I have bank statements showing that I paid \$199.28 to the Assessment line on 10-23-2019.

**Staff Comments:** The assessment office confirmed that the payment of \$199.28 that was made on 10/23/2019 was for the Quarter 3 2019 delinquent garbage assessment (\$110.48) and Quarter 2 2019 delinquent garbage assessment (\$4.80) as well as the annual sweeping and lighting fee (\$84.00). There have been no payments made since then. Therefore, staff recommends approving the assessment.
