**Comments:** Orders were issued to cut or remove a tree and vegetation which were overtaking the public sidewalk. The inspector issued three work orders: June 14, 2016 (prior to the compliance deadline), and two on June 30, 2016. Charges for the two cleanups are as follows: 7/7/16 - garbage abatement fee \$260, tree/brush disposal \$84, DSI admin fee \$120; 7/19/16 - tree removal \$750 and DSI admin fee \$120 (plus Real Estate and CAO admin fees where \$35 and \$5). The work order issued on June 14, 2016, prior to the compliance deadline, indicates by Parks on 7/14/16 that work was done by owner; inspector then issued a PAEC for \$120.
